

# • It is against the law to discriminate in Housing!

The New York State Human Rights Law prohibits discrimination based on several 'protected characteristics.'

- Race
- Creed
- Color
- National origin
- Sex
- Age
- Disability
- Marital status
- Military status
- Family status
- Sexual orientation
- Gender identity (as sex and/or disability discrimination)
- Alienage or citizenship status
- Pregnancy or Familial status
- Medical/Health status (including HIV/Aids)
- Victims of Domestic violence, Sexual abuse, stalking
- Wage history

- <u>WHY</u> do you think you are a victim of housing discrimination?
- <u>WHO</u> do you believe discriminated against you?
- WHERE did the alleged act of discrimination occur?
- <u>WHEN</u> did the last act of discrimination occur?

#### Actions that are Prohibited:

These laws apply to the sale or rental of housing and Mortgage lending. They cover but are not limited to:

- ✓ Refusing to rent, sell, finance, insure or negotiate for housing;
- ✓ Making housing unavailable;
- ✓ Setting different terms or conditions. Providing unequal services;
- ✓ Printing/circulating discriminatory advertisement;
- ✓ Refusing to provide information for a loan;
- ✓ Harassing, threatening, intimidating or coercing anyone (includes sexual harassment)
