#### RESOLUTION NO. 3 OF 2023 AWARD RETAINER AGREEMENT WITH WEST GROUP LAW PLLC FOR LEGAL SERVICES FOR GENERAL MATTERS OF THE ROCKLAND COUNTY SEWER DISTRICT NO. 1

**WHEREAS,** the District is desirous to enter into a retainer agreement with West Group Law PLLC (WGL) for legal services for General Matters of the Rockland County Sewer District No. 1, and,

**WHEREAS**, this agreement is for unforeseen legal matters that don't fall under other retainer agreements between the District and WGL, and,

**WHEREAS,** it is necessary to have expert legal advice available to assist with any issues that might arise, and,

WHEREAS, WGL submitted a cost proposal on January 17, 2023 in the amount of \$175,000, and,

**WHEREAS**, the staff of the District have reviewed WGL's proposal and found same to be acceptable, now, therefore, be it,

**RESOLVED**, that the Board of Commissioners, upon recommendation of the Executive Director, does hereby accepts the cost proposal from West Group Law, PLLC, 81 Main Street, Suite 510, White Plains, NY in the amount of \$175,000 for a retainer agreement for legal services for General Matters of the Rockland County Sewer District No. 1, and, be it,

**FURTHER RESOLVED,** that the Executive Director is authorized to execute such agreement after review by the staff of the Sewer District and the Office of the County Attorney, and, be it,

**STILL FURTHER RESOLVED**, that the Executive Director is authorized to forward said documents to the County Executive for forwarding to the Legislature for their approval.

#### **Item #7:**

M. Saber: The District needs skilled electrical/electronic personnel who are familiar with our equipment at the Wastewater Treatment Plant in Orangeburg and at the 27 Pump Stations and available to respond to emergencies during off hours. Mr. Philip Ammirati previously worked for the District in the title of Electronic Equipment Repairer. We currently have only one Electronic Equipment Repairer position filled but we will need this contract with Mr. Ammirati until that person is adequately trained. The District is currently recruiting for the other Electronic Equipment Repairer position.

The District requested a proposal from Mr. Ammirati's firm, Philip Ammirati Electrical Contractor, Inc. Based on Mr. Ammirati's past experience and the needs of the District, I recommend that this contract be awarded to his firm in an amount not to exceed \$35,000.

# RESOLUTION NO. 4 OF 2023 AWARD OF CONTRACT FOR ELECTRICAL SERVICES FOR ELECTRICAL AND ELECTRONIC EMERGENCIES AT THE WASTEWATER TREATMENT PLANT IN ORANGEBURG AND TWENTY-SEVEN (27) PUMP STATIONS WITHIN THE DISTRICT

**WHEREAS**, Rockland County Sewer District No. 1 (District) is desirous to enter into a contract with Philip Ammirati Electrical Contractor, Inc. for Electrical Services for Electrical and Electronic Emergencies at the Wastewater Treatment Plant in Orangeburg and at the Twenty-Seven (27) Pump Stations within the District, and,

**WHEREAS**, the contract is needed to ensure that the District has skilled electrical/electronic personnel available to respond to emergencies during off hours, and,

**WHEREAS**, at the present time, the District is short staffed for electrical positions including one Electronic Equipment Repairer and a Maintenance Mechanic – Electrical, and,

**WHEREAS**, Philip Ammirati of Philip Ammirati Electrical Contractor, Inc. has previously worked for the District in the title of Electronic Equipment Repairer and is familiar with the equipment at the WWTP and pump stations, and,

**WHEREAS**, Philip Ammirati Electrical Contractor, Inc. has submitted a cost proposal on January 13, 2023 to provide electrical services in the amount not to exceed \$35,000.00 and,

WHEREAS, the staff of the District have reviewed the proposal and found same to be acceptable, now, therefore, be it,

**RESOLVED**, that the Board of Commissioners, upon recommendation of the Executive Director, does hereby accept the proposal from Philip Ammirati Electrical Contractor, Inc. 150 North Middletown Road, Pearl River, NY for Electrical and Electronic Emergencies at the Wastewater Treatment Plant in Orangeburg and at the Twenty-Seven (27) Pump Stations within the District in the amount not to exceed \$35,000.00, and, be it,

**FURTHER RESOLVED**, that the Executive Director is authorized and directed to execute such documents as necessary to carry out the intent of this resolution after review by the staff of the Sewer District and the Office of the County Attorney.

The Wastewater Operator I would like to obtain their Grade 3A Wastewater Treatment Plant Operator certification. The District would pay for the travel and lodging. Veolia Water North America – Northeast, LLC, the District's manager of the wastewater treatment plant in Hillburn, will be paying for the course per our contract with them. I recommend that the District continues to support training of our employees so that they can

obtain the necessary wastewater operator license to progress into future positions. The cost is not to exceed \$4,800.

### AUTHORIZATION TO SEND A WASTEWATER OPERATOR I TO WASTEWATER TREATMENT PLANT OPERATOR COURSES AT MORRISVILLE COLLEGE IN MORRISVILLE, NY

**WHEREAS**, the wastewater treatment plant in Hillburn is staffed and on call 24/7 with Wastewater Operations and Maintenance Technician II, Wastewater Operations and Maintenance Technician I and Wastewater Operator I, and,

**WHEREAS**, the District would like to send Operators to courses offered at Morrisville State College to get their Wastewater Treatment Plant Operator Certifications, and,

**WHEREAS,** the District has a very difficult time trying to fill the Operator positions as there is a statewide shortage of licensed operators, and,

**WHEREAS**, these courses and experience from working in various Operator positions will qualify them to take the Wastewater Treatment Plant Operator Certification test, and,

**WHEREAS,** Veolia Water North America – Northeast, LLC, the District's manager of the treatment plant in Hillburn, will pay for the courses per the District's contract with them, and,

**WHEREAS**, the District will pay for the hotel, travel, and related expenses for a total amount of \$4,800.00, and,

**WHEREAS**, it is in the best interest of the District to approve the Wastewater Operator I to attend these courses to be able to obtain a Wastewater Treatment Plant Operator Certification since they are familiar with the treatment plant in Hillburn, now, therefore, be it,

**RESOLVED,** that the Board of Commissioners, Rockland County Sewer District No. 1, does hereby authorize the attendance of the Wastewater Operator I to attend Morrisville College to take the courses needed to obtain their Wastewater Treatment Plant Operator Certification, and, be it,

**FURTHER RESOLVED,** that Veolia Water North America – Northeast, LLC will pay for these courses and the District will pay for hotel, travel and related expenses at a cost not to exceed \$4,800.00, and, be it,

**STILL FURTHER RESOLVED,** that this training for the staff of the Sewer District No. 1 is subject to approval from the County Executive's Office.

#### **Item #10:** Quarterly Report

M. Saber: There's a report in your packet but I'll give you some of the highlights. The figures are preliminary as payments to vendors are still being processed against the 2022 budget. The Rockland County Finance Department still needs to record final journal entries.

Almost all expenses remained within the budgeted amount except for overtime. The overages should be offset by salary savings and fringes resulting from vacant positions.

While the report shows that we did not expend what was anticipated in all categories, I want to reiterate that additional entries will need to be recorded throughout.

Approximately, \$2,356,000 of the undesignated fund balance will be applied to the 2023 budget as per the adopted budget. Undesignated fund balance is estimated to be approximately \$9,826,000 after these adjustments and prior to any year-end adjustments.

M. Specht: Any questions for Executive Director Saber? Thank you, Mr. Saber

#### **Item #11:** Orangeburg Plant Performance

M. Saber: In your packet is a summary of the performance parameters of the wastewater treatment plant in Orangeburg. The CBOD limit of 85% removal had been met since May of 2022 but in December 2022 we did not meet the limit. Adjustments have been made and we are currently trending to pass this month.

- M. Specht: Very good. Any questions? Do we have any new business?
- G. Hoehmann: Mr. Chairman, I'm sorry Mike. Do you have anything else?
- M. Saber: I just want to make sure we go into Executive Session before we end the meeting.

M. Hoehmann: To go on the record as I meant to say something before. I meant to say in the haste to do the vote for the officers, I really want to thank all of the staff. Mike, it's been a pleasure working with you throughout these years. I know we'll continue to work together. Jean, you've been great really working with you, Marty, just tremendous, great in the role that you are there. Tommy, you've been a God send, a real great addition to the District. Teno, thank you. You've been a great advisor to all of us here at the District as well as with Rockland Green. Your work is incredibly valued. Of course, again, I want to thank the County Attorney's office as well and all the staff at the County Attorney's office throughout the years as Chairman. We're very fortunate to have very good and very dedicated staff. I wanted to put that on the record and thank them for their service during my time as Chairman.

M. Specht: I'd just like to thank again Commissioner Hoehmann for his outstanding stewardship as Chairman during his tenure as Chair and the great progress made by this Board on behalf of the County of Rockland. Thank you very much, George.

G. Hoehmann: Thank you. I'll offer a motion to go into Executive Session.
