Item #1: The meeting was called to order at 6:01pm.

M. Specht: Good evening, everybody. I'll call to order the meeting of the Rockland County Sewer District No. 1 Board of Commissioners for tonight, March 23, 2023. We'll start with the Pledge of Allegiance. I'm going to ask Commissioner Kenny to lead us in the pledge. Thank you.

Item #2: Roll Call M. Specht: I'll ask our clerk to call the roll. Thank you.

# Item #3: Public Participation – IWS Transfer Systems of NY

M. Specht: We have one Agenda item for Public Participation regarding IWS Transfer Systems. I'm going to ask our Executive Director if he can just inform the Board what the status of that is.

M. Saber: Is anybody here from IWS?

K. Thordahl: Yes, I am.

M. Saber: If you wouldn't mind, come up.

M. Saber: There's a letter in your packet with some of the circumstances. I'd like them to explain what they're doing moving forward and then I can give you some recommendation after that. If you wouldn't mind just explaining.

K. Thordahl: Sure. I'm Kristen Thordahl. I'm the engineer. I work with Cornerstone and I've worked with IWS for many years. IWS has a transfer station in Hillburn. They have a truck wash. We get sampled by the County. I've been working with Joan Roth. We've had exceedances with boron. When we found out that there were exceedances, we right away started to clean out the system and where it's coming from. We worked with Joan. We let her know that it we had it cleaned out. She went back and there were still exceedances. So then, we looked at the SDS of the soap that we're using. They used three (3) detergents at the time which is a prewash and two (2) soaps. We looked at the SDS. We didn't see boron in them listed on

the SDS but when I called them and spoke to the chemist, one of the detergents has a proprietary chemical in it. It's a mixture which includes boric acid. Prior to knowing this, we did do our own sampling. We got the results the other day. It did contain boron. It was like 3 mg per liter. As soon as we found out that the one soap had boric acid in it, they stopped using it. We are now planning on going back to resample to see if that was the actual cause of the boron.

M. Specht: When are you going to do the resampling?

K. Thordahl: When?

M. Specht: Yes.

K. Thordahl: In the next couple of weeks. We have the bottles. We were trying to get the system to flush itself out before we went back. When I did call the lab and spoke to the chemist, he did say there was a similar situation in California where they were using that soap and had that exceedance as well.

M. Specht: Thank you. Mr. Saber, is there anything else we should know about this?

M. Saber: I spoke with Ms. Roth earlier today and in the past, and basically it's what Ms. Thordahl laid out. When they're done and they're all setup after they're done with their sampling, we're going to go in and resample as per our protocols and then we'll see what those results lay out.

M. Specht: So, at this point, we don't have to take any action?

M. Saber: What I would recommend is that the Board pass a resolution putting the fines in abeyance at this point in time and seeing if it is the soap and see how the samplings results come out. After we get those results, they could come back and then we can either waive the fines at that point of time or I can give you a recommendation.

M. Specht: So, we could do that after we close Public Participation.

M. Saber: Yes.

M. Specht: Thank you very much. Is there anybody else that wishes to speak at Public Participation at this meeting tonight? It appears that there's nobody so I'll call for a motion to close Public Participation.

WHEREAS, bids for Contract RFB-RC-SWR-SM2023-03, 2023 Sewer System Maintenance Project – Hillcrest and Ramapo Interceptors were advertised and received on February 22, 2023, and,

WHEREAS, this contract is for sanitary sewer interceptor cleaning and televising, sewer manhole inspections, and miscellaneous additional work, and,

**WHEREAS**, in a memo dated February 22, 2023, Staff of the Sewer District has indicated that a total of two (2) bids were received as follows:

WHEREAS, the bid has been checked and tabulated by Staff of the Sewer District, and,

WHEREAS, National Water Main Cleaning Co. has submitted the lowest bid for the work described in the contract documents, and,

WHEREAS, National Water Main Cleaning Co. has completed similar projects for the Sewer District in the past in a satisfactory manner, now, therefore, be it,

**RESOLVED**, that the Board of Sewer Commissioners, upon the recommendation of the Executive Director, hereby awards Contract RFB-RC-SWR-SM2023-03, 2023 Sewer System Maintenance Project – Hillcrest and Ramapo Interceptors to National Water Main Cleaning Co., 1806 Newark Turnpike, Kearny, NJ, 07032 in the amount of \$621,293.70, and, be it,

M. Saber: If you don't mind, Mr. Chair, I'll take 6, 7, and 8 with the discussion together. Then you can vote on them individually.

M. Specht: You'll take them together, they're all related.

M. Saber: This project is for removing and replacing the existing internal components for the four (4) sludge thickeners at the plant in Orangeburg. Also, proposed are enhancements to provide operational flexibility such as re-routing of existing piping and adding the ability to pump from B-side to A-side sludge thickeners using existing pumps with temporary piping. The sludge thickeners and most of the auxiliary equipment are beyond economical repair.

For this project, \$4,900,000 is currently allocated. The project cost increase requested is \$2,200,000. The total project cost is estimated to be \$7,100,000 which includes engineering for design and construction administration services. The cost increases are mainly related to price increases for the equipment.

The resolutions are for the approval of engineering report, SEQRA, amending the capital budget, and requesting a public hearing for the increase in funds. If the Board recalls, back in September I had done something similar for the other projects and we had to come back a month later after we had a meeting with the County Executive's office and the Legislature. This week, the Chair and I met with some of the Legislature and County Executive's office to make sure this would be acceptable moving forward before we came to the Board. They agreed and we were all on

concurrence to move this forward so now I'm presenting to the Board. I would recommend that these resolutions be approved by the Board.

M. Specht: Thank you, Mr. Saber. So, we'll take them individually.

S. Lehman: I have a question.

M. Specht: Go ahead, Commissioner.

S. Lehman: Just from your understanding of the time line of this project, it started out in 2021. The Capital Budget was just over a million dollars at \$1.2 million. Now, we're going to over \$7 million. How do we think we can explain, comfortably, why the budget, besides the fact that you said parts and stuff, how do you see such a big change in just 2 years' time?

M. Saber: We have a Capital Improvement plan and the Capital Improvement Plan seems to have severely underestimated the projects. They appear to be equipment and not total project costs. So, a letter was drafted to be sent to the engineering firm with a couple of other issues that we had with them as far as costs go and responsiveness. The Chair signed it today. We're waiting from Law to give the final approval on the letter and then we're going to send it out to GHD. This isn't the only project that we're having this problem with. So, we're trying to get an answer as to why. The \$4.9 million was based on an engineering report and a year later, it went up \$2.2 million. I questioned the engineer and the material alone was over a million dollar increase from the manufacturer. They had gotten a quote from the manufacturer and the following year it went up a million dollars for just the material. So, we have a little bit of an added safety factor in there in case it goes up again because we're not going to be bidding this until later this year.

**WHEREAS,** proposed enhancements will provide operational flexibility such as re-routing of existing piping and adding the ability to pump from B-side to A-side sludge thickeners using existing pumps with temporary piping, and engineering design and construction administration services, and,

**WHEREAS,** the Sludge Thickeners Upgrade Project is included in the Rockland County 2023 Capital Budget (Capital Project #6330) in the amount of \$4,900,000, and,

WHEREAS, the total project cost is now estimated to be \$7,100,000 due to price increases for the equipment,

**FURTHER RESOLVED**, that the Executive Director is authorized and directed to execute such documents as may be necessary to carry out the intent of this resolution, after review by the Staff of the Sewer District and Office of the County Attorney, and, be it,

**STILL FURTHER RESOLVED**, that the Executive Director is authorized to forward said documents to the County Executive for forwarding to the Rockland County Legislature for their approval.

### Item #9:

M. Saber: The sewer mains on Twin Avenue in Spring Valley and the downstream sewer mains up to the Ramapo Interceptor are near capacity. The sewer mains will need to be increased in size. The District requested a proposal from Arcadis to prepare an engineering report for this project. The report will be used to request authorization for financing and SRF loans.

Arcadis is included on the County of Rockland's Qualified Suppliers List. Therefore, we were able to request pricing from them to perform the work as long as the cost does not exceed \$35,000.

I have reviewed the proposal. I recommend that the Board consider awarding a contract to Arcadis to perform the associated work in the amount of \$35,000.

### Item #11: Orangeburg Plant Performance

M. Saber: In your packet is a summary of some of the performance parameters of the wastewater treatment plant in Orangeburg. The CBOD limit of 85% removal had been met since May of 2022 but then in December 2022 and January 2023 we did not meet that limit. We did meet the limit for February and we are currently on the border for March. So, we're about 84% now. The reports are about five (5) days behind because it's about five (5) days to get results.

M. Specht: Thank you. Any questions for our Executive Director about this? One final item. On Tuesday, myself, Commissioner Hoehmann, Commissioner Simon, Commissioner Diaz, and our Executive Director attended the ceremony held in Stony Point to commemorate the transfer of the Split Rock property to The Land Conservancy. As you know, this was a long awaited final step in the process that began a number of years ago when Commissioner Hoehmann was Chairman. So, this is a really significant event. The County Legislators, and County Executive were there. Representatives of the Ramapo Lenape Nation were there. I'd say about sixty (60) people were in attendance, maybe more. It was a large crowd. There were talks about the archeological and spiritual significance to the property to the Ramapo Lenape Nation. People were very pleased that this Commission had taken the action to accomplish this. There was a sense that it was a very appropriate and long overdue resolution to that property. So, I wanted to just convey that to everybody. I'll ask Mr. Saber, do you wish to add anything about the event? M. Saber: You covered it pretty well. It was a very nice event.

M. Specht: Thank you. Very nice. The only thing that would have made it more ideal is if it was at the property, at the site, but it was nice to go to Stony Point too.
