**INSTRUCTION FOR HOMEOWNERS GENERAL WIRING PERMIT OF
SINGLE-FAMILY UNATTACHED PRIMARY RESIDENCE**

Homeowners of personally owned single-family unattached primary residence, (does not include townhouses, condominiums or co-ops), can take the Home Owners **General Wiring** exam and obtain a permit. A tenant or a friend cannot take the test for you. The test is given by appointment. Please call (845) 364-3904 to schedule the exam. Every failure is entitled to a review of the exam only by the Board of Electrical Examiners not by the applicant, provided they make an appeal in writing within 30 days after taking exam. A passing grade is 70%. There is a \$75.00 re-test fee if you do not receive a passing grade and wish to re-take the exam.

Homeowners' test is for renovation in existing home, **not for any new homes, pools, underground, overhead electrical service, generators or solar systems**. Test only covers inside of existing home limited to one or two rooms being redone, limited to outlets, lights and home runs back to panel.

Each of the several towns and villages in Rockland County has approved Electrical Inspection Agencies. It is imperative you contact your town and village for a list of these agencies before you schedule an inspection. Walls containing any electrical wiring or apparatus shall not be enclosed until after the initial rough in inspection is approved.

Application fee of **\$125.00 (CHECK OR MONEY ORDER payable to Board of Electrical Examiners – no cash)** for the administration of the test must accompany all applications. Questions on the test will be on General Wiring only in the National Electrical Code, 2014 Edition and one diagram to draw. **It will be a closed book test. Scrap paper, calculators, cell phones and palm pilots are not allowed. No exceptions. Drivers License to be presented as identification.**

The test will be held in the Office of Consumer Protection, Building A, 8th Floor. Enter from front entrance, 50 Sanatorium Road, Pomona, NY 10970.
