# **Item #1:** The meeting was called to order at 6:06 pm.

# RESOLUTION NO. 33 OF 2023 ADOPT MINUTES OF MEETING OF MAY 23, 2023

**WHEREAS,** S. Lehman offered the following resolution, which was seconded by G. Hoehmann and approved unanimously, now, therefore, be it,

**RESOLVED**, that the transcribed Minutes of the Rockland County Sewer District No. 1 Meeting of May 23, 2023, as recorded by the Clerk, are hereby adopted.

#### Item #5:

M. Specht: I'll ask Mr. Saber to discuss the proposed budget.

M. Saber: A preliminary budget was developed by staff of the Sewer District and presented to the budget committee. Four (4) options for fund balance release and corresponding user charges were presented to the committee. Option C was chosen and has a fund balance release of \$1,944,856. Prior to the appropriation, the amount in undesignated fund balance is estimated to be \$13,482,264 as of May 15, 2023. After the appropriation, the undesignated fund balance is estimated to be \$11,537,408.

The 2023 to 2024 user charge would be increased from \$323 to \$342 which is a 5.9% increase. The area benefit charges would be increased by 2.0%. The overall increase would be 4.5%. The total cost to the typical property owner in Ramapo would be \$438.23 and \$461.70 in Clarkstown, which is below the projected 2024 national average of \$618 as published by NACWA. The projected 2024 average annual sewer charge for New York/New Jersey is \$559 also published by NACWA.

The total 2024 budget as requested is \$47,416,385 which is \$2,336,275 higher than the adopted 2023 budget. Some of the increased costs are related to salary increases, increased debt service payments, projected chemical and utility increases, and increased repairs projected at the wastewater treatment plant in Orangeburg. As part of the salary increases, two (2) new positions are being requested. Material and equipment costs have increased. Contracts are coming in higher. Debt service payment for 2024 is up approximately \$800,000 from 2023 and nothing is coming off of the books until 2026.

#### **RESOLUTION NO. 35 OF 2023**

# REQUESTING THAT THE ROCKLAND COUNTY EXECUTIVE AUTHORIZE THE COMMENCEMENT OF AN ARTICLE 78 PROCEEDING AGAINST THE NEW YORK DEPARTMENT OF ENVIRONMENTAL CONSERVATION

**WHEREAS**, the Rockland County Sewer District No. 1 (the "District"), is a county sewer district, duly organized and existing under Article 5-A of the County Law of the State of New York, and,

**WHEREAS**, the District is the Permittee for the State Pollutant Elimination Systems (SPDES) permit No. NY0031895 covering the wastewater treated at the District's Orangeburg Wastewater Treatment Plant (the "Treatment Plant"), and,

**WHEREAS**, the District applied for a permit renewal on January 10, 2014, to continue discharging at the Hudson River Outfall 001 in Piermont, New York, and,

**WHEREAS**, On June 7, 2018, the New York State Department of Environmental Conservation (the "Department"), issued a Notice of Complete Application and Draft Permit in conjunction with the District's application for permit renewal (the "2018 Draft Permit"), and,

**WHEREAS**, the 2018 Draft Permit contained even more restrictive changes to the ammonia effluent limits than the District's previous SPDES permit which would require making significant upgrades to the District's wastewater treatment facilities, and,

**WHEREAS**, the District and the Department had multiple meetings and conversations regarding the appropriate final ammonia limits, and,

**WHEREAS**, on August 26, 2020, the Department issued an updated draft permit which included the even more restrictive 2018 Draft Permit ammonia effluent limits (the "2020 Updated Draft Permit"), and,

**WHEREAS**, the District timely requested an adjudicatory hearing from the Department to appeal the Department's issuance of the final permit but the Department denied the District an adjudicatory hearing, and,

WHEREAS, on June 21, 2023, the Department issued the final SPDES permit, and,

**WHEREAS**, pursuant to Section 17-0909 of the Environmental Conservation Law, the District has sixty (60) days from the date of service of the determination/decision to file an action against the Department (June 6, 2023), and,

WHEREAS, the District has exhausted all administrative remedies, and,

**WHEREAS**, the County of Rockland (the "County") has retained West Group Law PLLC ("West") to represent the District and County in all matters regarding the District's SPDES permit, and,

WHEREAS, West has represented the District at each step of this process, and,

**WHEREAS**, the County Executive of the County has sole discretion over whether to file suit over this matter, now, therefore, be it,

**RESOLVED**, that the Sewer Board of Commissioners (the "Board") and the District hereby formally requests that the County Executive of the County authorizes the commencement of an Article 78 Proceeding against the Department, challenging the issuance of the final SPDES permit and the denial of the adjudicatory hearing, and, be it.

**FURTHER RESOLVED**, that the Board and the District authorizes the District's Executive Director to prepare and execute such documents as may be necessary to carry out the intent of this resolution, and, be it,

**STILL FURTHER RESOLVED**, that the Executive Director is authorized to forward said documents to the County Executive and the County Attorney for their approval.
