RESOLUTION NO. 67 OF 2023 ADOPT MINUTES OF MEETING OF NOVEMBER 16, 2023

WHEREAS, P. Carroll offered the following resolution, which was seconded by J. Tursi and approved unanimously, now, therefore, be it,

RESOLVED, that the transcribed Minutes of the Rockland County Sewer District No. 1 Meeting of November 16, 2023, as recorded by the Clerk, are hereby adopted.

M. Saber: The rates are the same as what was approved by the Board for the 2024 Budget back in June. The increase is \$323.00 to \$342.00 for the user rate which is a 5.9% increase. The area benefit charges are increased by 2% with the overall increase to be 4.5%. Based on some adjustments to earnings on investments, approximately, \$1,105,000 versus the originally \$1,944,856 is allocated from undesignated fund balance for the 2024 budget. After this release from fund balance, approximately \$12,017,099 is remaining. An additional \$200,000 may be used from fund balance for next year to cover contractual increases that were recently approved by the County Executive, Legislature, and unions. I request that the Board approve this resolution.

RESOLUTION NO. 72 OF 2023 RECOMMENDED RATES FOR USER CHARGES AND AREA BENEFIT CHARGES FOR 2024

WHEREAS, the Rockland County Sewer District No. 1 has submitted its budget for calendar year 2024 for incorporation in the budget submitted by the County Executive to the Legislature of Rockland County, and,

WHEREAS, information has been received from the Town of Clarkstown, the Town of Ramapo, and the Town of Orangetown concerning assessed value and number of units of use within each municipality, and,

WHEREAS, equalization rates for the Towns of Clarkstown, Ramapo, and Orangetown have been received by the Clerk to the Legislature from the New York State Board of Equalization for use in computing Sewer District charges only, and,

WHEREAS, all said information has been used in computation of User and Area Benefit Charges, and,

WHEREAS, these rates have been audited and verified by the Accountant to the Sewer District, the Sewer Commission Budget Committee, and the Executive Director, now, therefore be it,

RESOLVED that the Executive Director, Rockland County Sewer District No. 1, hereby recommends that the government of Rockland County adopt the following charges:

STILL FURTHER RESOLVED, that the Executive Director is authorized to forward said documents to the County Executive for forwarding to the Legislature for their approval.

M. Saber: This is the annual project in the Village of Spring Valley which consists of replacing sanitary sewers, reconstructing house service connections with lateral piping and clean outs, and performing required testing of new pipes.

Sixty-one (61) Plan Holders accessed and/or downloaded the Bidding Documents at the website.

Eight (8) bids were received on November 15, 2023. The lowest responsive and responsible bidder is Southern Industries Corporation at \$189,931.25. References were checked and we did verify that they could perform the work at the price given. I recommend that the Board award this contract.

RESOLUTION NO. 73 OF 2023 AWARD OF CONTRACT RFB-RC-SWR-2024-02 2024 SPRING VALLEY SEWER SYSTEM REHABILITATION

WHEREAS, bids for Contract RFB-RC-SWR-2024-02, 2024 Spring Valley Sewer System Rehabilitation were advertised and received on November 15, 2023, and,

WHEREAS, this contract is to replace two (2) segments of approximately 409 linear feet of 8" sewer pipe at Ewing Street in the Village of Spring Valley; reconstruct house service connections; provide 6" diameter PVC lateral pipe with clean out, televising and testing of sewer lines, and miscellaneous additional work, and,

WHEREAS, the work is located in the Village of Spring Valley, Rockland County, New York, and,

WHEREAS, in a memo dated November 29, 2023, the Staff of the Sewer District has indicated that a total of eight (8) bids were received as follows:

WHEREAS, Southern Industries Corp.'s bid was significantly lower than the engineers estimate and the other seven (7) bidders, and,

WHEREAS, the District had a discussion with Southern Industries Corp. regarding variances in their bid proposal, and,

WHEREAS, Southern Industries Corp. confirmed to the District that they could complete the project for their submitted bid proposal, and,

WHEREAS, references for Southern Industries Corp. have been checked and they have completed similar projects in the past in a satisfactory manner, now, therefore, be it,

RESOLVED, that the Board of Sewer Commissioners, upon the recommendation of the Executive Director, hereby awards Contract RFB-RC-SWR-2024-02, 2024 Spring Valley Sewer System Rehabilitation to Southern Industries Corp. 520 White Plains Road, Suite 500, Tarrytown, NY 10591 in the amount of \$189,931.25, and, be it,

FURTHER RESOLVED, that the Executive Director is authorized and directed to execute such documents as may be necessary to carry out the intent of this resolution, after review by the Staff of the Sewer District and the Office of the County Attorney, and, be it,
