WHEREAS, Change Order No. 1, Contract RFB-RC-SWR-SM2022-01 with Vortex Services LLC for 2022 Sewer System Maintenance Project has been proposed, and,

WHEREAS, the project was for Sewer System Maintenance in the Towns of Clarkstown and Ramapo which consists of sanitary sewer cleaning, televising, testing and sealing; manhole sealing; manhole chimney seals; and miscellaneous additional work, and,

WHEREAS, the Summary of Change to Contract involves a decrease to the contract in the amount of \$430,736.50 due to reduction in quantities and a 356 day no cost extension of time to the contract, and,

WHEREAS, due to the contractors delay schedule and performance, the Sewer District incurred additional costs including onsite inspection, in-house report review and data collection, oversight, and supervision, and,

WHEREAS, the Sewer District withheld the amount of \$41,755.05 to compensate for these additional costs, and,

WHEREAS, Change Order No. 1 decreases the total contract amount to \$793,346.00, and,

WHEREAS, the staff of the Sewer District has participated in discussions concerning Change Order No. 1 and has reviewed the details and found them acceptable, now, therefore, be it,
