### MISSION AND GOALS

The Rockland County Water-Quality Strategy Committee was formed to create a communications network for organizations interested in water quality.

The goals of the committee are to:

- Identify existing and potential nonpoint source problems, and formulate the procedure for addressing the problems;
- Inform government officials, business representatives, and residents of the impact of activities which result in nonpoint source pollution and best management practices that prevent nonpoint source pollution through educational programs.
- Enhance the communication between regulatory and elected/appointed officials in order to properly manage the potential nonpoint sources. Through the education and information exchange with all the various interest groups within the county, it is the committee's view that a proactive approach in addressing nonpoint source pollution is much more cost effective than the "after-the-fact" approach. This view then becomes the mission, which is to eliminate, or mitigate, nonpoint source pollution before it occurs. This can only happen by building cooperation among all the affected parties.

### **FUNCTIONS**

The functions of the committee are to:

- 1. Create a forum where organizations, municipalities, and individuals interested in water quality can meet to share knowledge, resources, expertise, challenges and opportunities related to improving the quality of water and reducing nonpoint source pollution in Rockland County.
- 2. Build a working coalition dedicated to changing the behaviors that result in nonpoint source and other forms of water pollution. The committee will develop a team approach to reduce nonpoint source pollution of county bodies of water, especially those on NYSDEC Priority Water Problem List, and advocate for the adoption of municipal ordinances designed to reduce nonpoint source pollution.
- 3. Develop and carry out a plan of action to reduce nonpoint source and other forms of water pollution that include identifying gaps and overlaps in programs, activities, and regulations; coordinating and implementing educational programs and activities; integrating new programs, activites and regulations within the work of the committee; identifying bodies of water for addition to the Priority Water Problem List; and publicizing the activities and results.
- 4. Advise municipalities on water quality problems related to nonpoint source pollution and make them aware of best management practices that mitigate those problems.
