OLD BUSINESS:

Violation 23-195LC Appeal of hearing decision to the Board:

A notice of violation was issued against Darren Walker for violating Section 250-3, Electrical License Required, of the Rockland County Local Law by advertising on a Rockland County Community Facebook page without holding a Rockland County electrical license. A hearing pertaining to this violation was held on 4/20/2023. Hearing decision was made on 12/29/2023 reducing the original civil penalty of \$3000.00 to \$1,000.00 payable by 1/19/2024. Mr. Walker explained to the Board that he made the post in search of work because of a financial hardship. He stated that the post was removed as soon as he realized it violated the law and advised that he did not perform any work. Motion by J. Siedel to reduce fine to \$500.00 and must be paid by June 20, 2024, seconded by R. Marino. All in favor.

James Mullen - E-351 Reactivation of Shelved License and Name Change from HVS LLC to James Mullen (Sole Proprietor):
