NYSDEC Endorsed 4-Hour Erosion and Sediment Control **Required** Training **Wednesday, December 18, 2024**

Under the NYS Department of Environmental Conservation's General Permit GP-0-20-001, all developers, contractor and subcontractors must identify at least one *Trained Contractor* from their company that will be responsible for implementation of the SWPPP, and have at least one *Trained Contractor* on site on a daily basis when soil disturbance activities are being performed. Also, developers must have a *Qualified Inspector* conduct regular site inspections in accordance with GP-0-20-001.

Qualified Inspectors and *Trained Contractors* must attend 4 hours of training in the principles and practices of erosion and sediment control endorsed by NYS DEC every 3 years.

Upon completion, each participant will receive a NYSDEC SWT number, valid for 3 years.

Training is required for those who are not CPESC, LA, or PE certified.

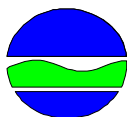

The trainee must be prepared to show his/her NYS Driver License (or non-driver photo ID with proof of address) on the day of training to verify that the information below is correct. NYSDEC recommends that this form be completed as a PDF form on computer (or hand-written in blue or black ink) and sent to the training sponsor by the pre-registration deadline (in advance of the training) either by email or through the mail.
