

WORKING FAMILIES PARTY PARTY CALL Election Law § 2-120



STATEMENT OF PARTY POSITIONS TO BE FILLED BY THE WORKING FAMILIES PARTY AND THE NUMBER OF PERSONS TO BE ELECTED TO EACH SUCH PARTY POSITION AT THE OFFICIAL PRIMARY ELECTION TO BE HELD ON THE 28th DAY OF JUNE, 2022.

TO THE STATE BOARD OF ELECTIONS AND THE BOARDS OF ELECTIONS IN EACH COUNTY:

I, Jessica Wisneski, Co-Chair of the State Committee of the Working Families Party and pursuant to the authority vested in the aforesaid office and in accordance with the provisions of the Election Law and the Rules and Regulations of the Working Families Party and the rules and procedures of the New York State Board of Elections do hereby

CERTIFY and deliver to and file with the State Board of Elections and the Board of Elections in each County this amended statement of party positions to be filled by the Working Families Party and the number of persons to be elected to each of such party positions and for and to which qualified and enrolled voters of the Working Families Party are to be elected at the official primary election to be held in the aforesaid State on the 28th day of June, 2022.

The party positions for which qualified and enrolled voters of the Working Families Party are to be designated in accordance with the provisions of the Election Law and to which they are to be elected at the official primary election to be held in New York State on the 28th day of June, 2022 are:

- (a) Members of the New York State Committee of the Working Families Party.
- (b) Delegates to the Judicial District Conventions of the Working Families Party.
- (c) Alternate Delegates to the aforesaid Judicial District Conventions of the Working Families Party.

A breakdown by districts of the party positions to be filled follows:

Members of the State Committee of the Working Families Party of New York State

Pursuant to Article II, Sections 1 and 2 of the Rules of the Working Families Party of New York State, there shall be twelve members of the State Committee elected from each Congressional District ("CD") of New York State to the State Committee of the Working Families Party, with no more than six identifying as male and no more than six identifying as female.

Candidates for State Committee identifying as male or female are requested to indicate such identification on their nominating petitions. Candidates who do not indicate such identification are presumed not to identify as male or female.

Delegates and Alternate Delegates To Judicial District Conventions

Pursuant to Article VIII, Section 4 of the Rules of the NY State Committee of the Working Families Party: Each Assembly District ("AD") or part of an AD contained within the subject Judicial District ("JD") shall elect one delegate and one alternate, and one additional delegate and one additional alternate delegate for every 1,000 votes or major fraction thereof cast on the Working Families Party line or column in the last preceding general election for Governor in that portion of the subject AD contained within the subject JD; each delegate and each alternate delegate shall be an enrolled member of the Working Families Party and shall reside within the JD from which such delegate or alternate delegate is elected.
